Bus Purchase options Without a Wisconsin Clean Diesel Grant

Mr. Denk stated the District was not selected for the Wisconsin Clean Diesel Grant program. Mr. Denk has applied for the EPA School Bus Replacement Rebate Program and we are #411 of #420 on the waiting list. Alternative options within the current budget are being explored. No action taken.

2017-18 School Calendar

The school calendar for 2017-18 with a start date of September 5, 2017 was reviewed. The preliminary draft was approved with a motion from Tim Urness and seconded by Jackson Serum. Motion carried 5-0. The final draft will be presented at the February 16, 2017 meeting.

Special & Regular Education Open Enrollment Spaces for 2017-18

Tammi Olson made the motion to approve the following 2017-18 Open Enrollment Policy:

The School Board of the School District of Gilmanton will accept all applications for open enrollment until the maximum class size by grade for the District are reached. The maximum class sizes are specified as follows: 4K: 12, 5K: 12, Grades First through Fourth: 15, Grades Fifth through Twelfth: 25.

A prior resident student who was a habitual truant during either semester in the current school year and moves out of the Gilmanton School District and then applies for Open Enrollment to the Gilmanton School District and qualifies as habitual truant under Wisconsin Act 304 may be denied Open Enrollment to the Gilmanton School District in the succeeding semester or school year.

After a review of spaces available for Middle School /High School Special Education in the Gilmanton District considering current enrollment, projected enrollment for the 2017-18 academic year , and WI DPI "Options for Determining Caseloads in Special Education (2001) chart (pages 6&7)" the following spaces were determined to be open in the School District of Gilmanton for the 2017-18 academic year: Middle School /High School Special Education: 7 and in the Gilmanton Elementary Special Education: 3.

The School District of Gilmanton contracts out of District for the following: Deaf and Hard of Hearing (DHH), Visual Impairment (VI), Early Childhood (EC), Speech & Language, Intellectual Disability (ID), Occupational Therapy (OT), Physical Therapy (PT), and Audiology, and Interpretation.

All IEPs will be reviewed by the Director of Special Education and/or appropriate district staff to determine if the student's special education and related service needs as stated in the IEP can be met within the District prior to approval.

Diane Ross seconded the motion. Motion carried 5-0.
