Approval of Consent Agenda

Diane Ross made the motion to approve the contract for Glen Denk for the 2017-18 school year with a .43% salary increase and to approve the contract for Kory Rud for the 2017-18 school year with a 3.11% salary increase. The motion was seconded by Justin Henthorn. Motion carried 5-0.

2018-19 School Calendar

Special & Regular Education Open Enrollment Spaces for 2018-19

Jackson Serum made the motion to approve the following 2018-19 Open Enrollment Policy:

The School Board of the School District of Gilmanton will accept all applications for open enrollment until the maximum class size by grade for the District are reached. The maximum class sizes are specified as follows: 4K: 18, 5K: 18, Grades First through Fourth: 18, Grades Fifth through Twelfth: 25.

A prior resident student who was a habitual truant during either semester in the current school year and moves out of the Gilmanton School District and then applies for Open Enrollment to the Gilmanton School District and qualifies as habitual truant under Wisconsin Act 304 may be denied Open Enrollment to the Gilmanton School District in the succeeding semester or school year.

After a review of spaces available for Middle School /High School Special Education in the Gilmanton District considering current enrollment, projected enrollment for the 2018-19 academic year, and WI DPI "Options for Determining Caseloads in Special Education (2001) chart (pages 6 &7)" the following spaces were determined to be open in the School District of Gilmanton for the 2018-19 academic year: Middle School /High School Special Education: 6 and in the Gilmanton Elementary Special Education: 0.

The School District of Gilmanton contracts out of District for the following: Deaf and Hard of Hearing (DHH), Visual Impairment (VI), Early Childhood (EC), Speech & Language, Intellectual Disability (ID), Occupational Therapy (OT), Physical Therapy (PT), and Audiology, and Interpretation.

All IEPs will be reviewed by the Director of Special Education and/or appropriate district staff to determine if the student's special education and related service needs as stated in the IEP can be met within the District prior to approval.

Justin Henthorn seconded the motion. Motion carried 5-0.
