Approval of Consent Agenda

Justin Henthorn made the motion to approve the Consent Agenda. Diane Ross seconded the motion. The December 17, 2018, Open Session minutes and the monthly vouchers in the amount of \$110,063.26 were approved. Gifts from the Loren Gunderson Family for \$1,000.00 toward the athletic program and an anonymous donation of \$300.00 toward student lunch accounts were accepted. 2019-20 School Calendar

The school calendar for 2019-2020 drafts 1 and 2 were reviewed. Draft 1 was approved with a motion from Justin Henthorn and seconded by Diane Ross. Motion carried 5-0.

Special & Regular Education Open Enrollment Spaces by Grade for 2019-20

Justin Henthorn made the motion to approve the following 2019-2020 Open Enrollment Policy ---

The School Board of the School District of Gilmanton will accept all applications for open enrollment until the maximum class size by grade for the District are reached. The maximum class sizes are specified as follows: 4K: 18, 5K: 18, Grades First through Fourth: 18, Grades Fifth through Twelfth: 25.

A prior resident student who was a habitual truant during either semester in the current school year and moves out of the Gilmanton School District and then applies for Open Enrollment to the Gilmanton School

District and qualifies as habitual truant under Wisconsin Act 304 may be denied Open Enrollment to the Gilmanton School District in the succeeding semester or school year.

After a review of spaces available for Middle School /High School Special Education in the Gilmanton District considering current enrollment, projected enrollment for the 2019-20 academic year, and WI DPI "Options for Determining Caseloads in Special Education (2001) chart (pages 6 & 7)" the following spaces were determined to be open in the School District of Gilmanton for the 2019-20 academic year: Middle School /High School Special Education: 5, and in the Gilmanton Elementary Special Education: 0.

The School District of Gilmanton contracts out of District for the following: Deaf and Hard of Hearing (DHH), Visual Impairment (VI), Early Childhood (EC), Speech & Language, Intellectual Disability (ID), Occupational Therapy (OT), Physical Therapy (PT), and Audiology, and Interpretation.

All IEPs will be reviewed by the Director of Special Education and/or appropriate district staff to determine if the student's special education and related service needs as stated in the IEP can be met within the District prior to approval.

Tammi Olson moved to amend the motion to have no open enrollment space limitation for grades 5 through 12.

The School Board of the School District of Gilmanton will accept all applications for open enrollment until the maximum class size by grade for the District are reached. The maximum class sizes are specified as follows: 4K: 18, 5K: 18, Grades First through Fourth: 18, Grades Fifth through Twelfth: no limitation.

Jackson Serum seconded the motion to approve the motion as amended. Motion carried 5-0.
