Salary/Wage/Fringes for the 2024-25 Fiscal Year

Administrative salaries were moved to closed session with a motion by Jeremiah Bauer seconded by Lance Peterson.

At 8:42 pm Jackson Serum made the motion to move to closed session pursuant to Wisconsin Statues 19.85 (1) (c) (e) (f). Lance Peterson seconded the motion. Motion carried by roll call vote 5-0.

Open Session reconvened at 10:12 pm with a motion by Jeremiah Bauer seconded by Lance Peterson. Motion carried 5-0. The following motions were made when Open Session reconvened:

Jeremiah Bauer made the motion to increase salaries for teaching staff by 4.12%. Jackson Serum seconded the motion. Motion carried 5-0.

Jeremiah Bauer made the motion to increase wages for support staff by 4.12%. Jackson Serum seconded the motion. Motion carried 5-0.

Jeremiah Bauer made the motion to increase extra duty pay by 4.00%. Jackson Serum seconded the motion. Motion carried 5-0.

The Dean of Students contract was approved with a salary increase of 22.7% with a motion by Jeremiah Bauer, seconded by Jackson Serum. Motion carried 5-0.

The District Administrator's contract was approved with a salary increase of 11.1% with a motion from Jeremiah Bauer, seconded by Jackson Serum. Motion carried 5-0.

The District Principal's contract was approved with a salary increase of 7% with a motion from Jeremiah Bauer, seconded by Jackson Serum. Motion carried 5-0.

The Transportation/Maintenance Coordinator's salary was increased 4.12% with a motion by Jeremiah Bauer, seconded by Jackson Serum. Motion carried 5-0.

Employee Handbook for Professional Staff and Support Staff Yearly Updates

Various sections of the handbook were reviewed and discussed. Updates as suggested were approved with a motion by Lance Peterson seconded by Jeremiah Bauer. Motion carried 5-0.

2023-24 Budget Transfers

Lance Peterson made the motion to approve an \$8,700 budget transfer from function 100000 to function 400000 and \$48,300 from function 200000 to 400000. Jackson Serum seconded the motion. Motion carried 5-0.

Gym Entrance Lobby Roof Bids

Bids were reviewed for the gym entrance lobby roof. Lance Peterson made a motion to accept the bid from JMS Construction to install a steel roof for \$8,000. Jeremiah Bauer seconded the motion. Motion carried 5-0.
