Music Teacher Resignation

Lance Peterson made the motion to accept Bill Bocian's resignation from the music teaching position effective Friday, January 26, 2024. Jeremiah Bauer seconded the motion. Motion carried 5-0.

2024-2025 School Calendar

The draft school calendar for 2024-25 school year was reviewed. The draft was approved with a motion from Jackson Serum and seconded by Lance Peterson. Motion carried 5-0.

Special & Regular Education Open Enrollment Spaces for 2024-2025

The School Board of the School District of Gilmanton will accept all applications for open enrollment until the maximum class size by grade for the District is reached. The maximum class sizes are specified as follows: 4K through Twelfth: no limitation. Using these maximum class sizes, there are the following spaces open: 4Kthrough 12th: unlimited spaces. A motion to approve unlimited regular education open enrollment spaces for 2024-25 was made by Jeremiah Bauer and seconded by Jackson Serum. Motion carried 5-0.

A motion to approve 2 Special Education spaces in Cross Categorical Special Education in 2024-25 for grades 4 K-12 was made by Jackson Serum and seconded by Lance Peterson. Due to the district's caseload formulas, there are no other spaces available in any special education services at any grade level other than what is listed above. This formula is based on the students with IEPs to special education teacher ratio of 15:1. For non-resident students wishing to open enroll, services are

limited to Gilmanton School District's existing special education programs. The District does not currently have special education programming for students with IEPs receiving 1:1 services, and it partners with neighboring districts to provide more intensive services to students. More intensive special education services are considered to be outside of Gilmanton School District's existing special education programs.

The School District of Gilmanton contracts out of District for the following: Deaf and Hard of Hearing (DHH), Visual Impairment (VI), Early Childhood (EC), Speech & Language, Intellectual Disability (ID), Occupational Therapy (OT), Physical Therapy (PT), and Audiology, and Interpretation.

All IEPs will be reviewed by the Director of Special Education and/or appropriate district staff to determine if the student's special education and related service needs as stated in the IEP can be met within the District prior to approval.

Motion carried 5-0.

Tax and Revenue Anticipation Promissory Note

Jeremiah Bauer made the motion to renew the \$650,000 short-term borrowing loan. The loan is only used in the need for cash flow becomes evident. Jackson Serum seconded the motion. Motion carried 5-0.

Elementary School Boiler Bids

Jamey Davis reviewed the bids received for the Elementary School boiler replacement. Jackson Serum made the motion to accept the bid from Winona Heating (lowest bid) for the boiler replacement at the Elementary School. Lance Peterson seconded the motion. Motion carried 5-0.

Wisconsin Rural Schools Alliance

After a brief overview of the Wisconsin Rural Schools Alliance Tammi Olson made the motion to pay the \$500 membership fee to join the WRSA. Jeremiah Bauer seconded the motion. Motion carried 4-1.
