Resolution 2020 D Authorize temporary loans for operational expenses: Motion by Becky Hallock, seconded by Diane Ross to authorize the Board to obtain temporary loans for operational expenses if deemed necessary. Motion carried by voice vote.

Resolution 2020 E Disposal of surplus property: Motion by Jeremiah Bauer, seconded by Becky Hallock to authorize the Board to dispose of unused or no longer needed equipment and materials if the Board deems necessary. Motion carried by voice vote.

Resolution 2020 F Authorize student accident insurance for the 2021-2022 school year: Gentry Jesse made a motion which was seconded by Kory Rud to provided student accident insurance for the 2021-2022 school year. Motion carried by voice vote.

Resolution 2020 G Authorize Board to defend legally: Motion by Diane Ross, seconded by Jeremiah Bauer to authorize the School Board to legally defend the District and its interests. Motion carried by voice vote.
